

CONSENT FORM FOR PARTICIPATION



This form must be signed by a parent or legal guardian for participants under 18 years of age. Participants aged 18 or older may sign it themselves.

1.PERSONAL DATA COLLECTED AND PROCESSED?

The organizer may collect the following personal data:

- Participant’s details: full name, date of birth, gender, school, institution, phone number, contact email, copy of ID or passport
- Parent/guardian details (if applicable): full name, email address, phone number
- Multimedia content: photographs, video, and audio recordings captured before ,after or during the event

2. PURPOSE OF DATA PROCESSING

Collected data will be used exclusively for the following purposes:

- Event organization and management
- Communication with parents/guardians (if applicable)
- Verification of eligibility to participate
- Ensuring participants’ safety and health
- Publishing results and promoting the event
- Generating statistics, reports, and post–event analysis
- Other lawful purposes connected with the event and its promotion

3. LEGAL BASIS FOR DATA PROCESSING

The processing of data is based on:

- The consent of the participant or their parent/legal guardian (Article 6(1)(a) GDPR)
- Fulfillment of legal or contractual obligations (Article 6(1)(b))
- The legitimate interests of the organizer for event promotion (Article 6(1)(f))

4. USE OF PHOTOGRAPHS AND RECORDINGS

I hereby give explicit consent for the use of photographs, videos, and audio recordings taken during the event for the following purposes:

- Publication on official ESG platforms (e.g., website, social media, promotional materials)
- Press and media coverage
- Archival purposes and promotion of future events
- Other lawful purposes related to ESG promotion

No financial compensation will be provided for the use of these materials.

5. DATA ACCESS, TRANSFER, AND STORAGE

Personal data will only be accessed by authorized members of the ESG organizing team and designated third-party service providers supporting the event. Data will not be transferred outside the European Union unless adequate legal safeguards are in place.

6. DATA RETENTION

Personal data will be stored for up to six (6) months after the event unless a longer retention period is required by law or justified for legitimate purposes (e.g., promotional materials).
